From the North West: Take the William Natcher Parkway South from Owensboro, KY to Hwy 70, go east on 70 to 1328, right on 1328 to 2266, left on 2266 to running grounds.

From the South: Take I-65 North to Bowling Green, KY, take Hwy 185 North from Bowling Green to Hwy 70, go left on 70 to 1328, left on 1328 a few hundred feet to 2266, left on 2266 to running grounds.
