Running Grounds: UBGF National Grounds, 1150 Millshed Road, Jetson, KY (for GPS purposes)  
Host Club: Butler County Beagle Club, Morgantown, KY

Directions: From the North East: Take I-65 South from Louisville to Western Kentucky Parkway, go West to Highway 79, go South on 79 to Highway 70, East (left) on 70 to 1328, right on 1328 a few hundred feet to 2266, left on 2266 to running grounds.

From the North West: Take the William Natcher Parkway South from Owensboro, KY to Hwy 231 East, go east on 231 to Highway 70, turn left on 70 to 1328, right on 1328 to 2266, left on 2266 to running grounds.

From the South: Take I-65 North to Bowling Green, KY, take Hwy 185 North from Bowling Green to Hwy 70, go left on 70 to 1328, left on 1328 a few hundred feet to 2266, left on 2266 to running grounds.
